

**DEMOCRATIC PRIMARY RUNOFF ELECTION**  
**MAY 22, 2018**

**IMPORTANT DATES TO REMEMBER FOR THE UPCOMING ELECTION:**

**MONDAY, APRIL 23, 2018:**

**LAST DAY** to register to vote or make a change of address effective for the Tuesday, May 22, 2018 Primary Runoff Election.

**FRIDAY, MAY 11, 2018:**

**LAST DAY** for early voting clerk to receive Applications for a ballot to be voted by mail. All applications to vote by mail **must** be received by the early voting clerk before the close of regular business or 12 noon, **whichever is later**. Applications to vote by mail must be submitted by mail, common or contract carrier, fax or e-mail (Please note: I can receive the application by e-mail, BUT, I cannot e-mail the ballot to you). **MONDAY, MAY 14, 2018:**

**FIRST DAY** to vote early in person.

Early Voting in person will be conducted in the County Clerk's Office, 300 Lacaverna St., during regular business hours.

**HERE IS A LIST OF THE ACCEPTABLE FORMS OF PHOTO ID:**  
(Photo ID must be current OR expired no more than four years)

- Texas driver license issued by the DPS
- Texas Election Identification Certificate issued by DPS
- Texas personal identification card issued by DPS
- Texas license to carry a handgun issued by DPS
- U.S. military identification card containing the person's photograph
- U.S. citizenship certificate containing the person's photograph

- U. S. passport

HERE IS A LIST OF THE SUPPORTING FORMS OF ID THAT CAN BE PRESENTED IF THE VOTER DOES NOT POSSESS ONE OF THE FORMS OF ACCEPTABLE PHOTO ID AND CANNOT OBTAIN ONE DUE TO A REASONABLE IMPEDIMENT:

- Valid voter registration certificate
- Certified birth certificate (must be an original)
- Copy of OR original current utility bill
- Copy of OR original bank statement
- Copy of OR original government check
- Copy of OR original paycheck
- Copy of OR original government document with your name and an address (original required if it contains a photograph)

After presenting a supporting form of ID, the voter must execute a Reasonable Impediment Declaration form.

**FRIDAY, MAY 18, 2018:**

LAST DAY to vote in person.

**TUESDAY, MAY 22, 2018:**

Primary Runoff Election Day.

Polling places will open at 7:00 am and will close at 7:00 pm.
