## **IMPORTANT DATES TO REMEMBER FOR THE UPCOMING ELECTION:**

## FRIDAY, OCTOBER 26, 2018:

LAST DAY for early voting clerk to receive Applications for a ballot to be voted by mail. All applications to vote by mail <u>must</u> be received by the early voting clerk before the close of regular business or 12 noon, <u>whichever is later</u>.

(NEW LAW: If an ABBM is faxed or emailed or if an FPCA is faxed, then the applicant MUST submit the ORIGINAL application BY MAIL to the early voting clerk so that the early voting clerk receives the ORIGINAL no later than the 4<sup>th</sup> business day after receiving the emailed or faxed ABBM or faxed FPCA. If the early voting clerk does NOT receive the original ABBM or FPCA by that deadline, then the emailed or faxed ABBM or faxed ABBM or faxed ABBM or faxed incomplete, and the early voting clerk may NOT send the applicant a ballot.

Applications to vote by mail must be submitted by mail, common or contract carrier, fax or e-mail. The fax number is - 432-283-2091 and the e-mail address is - <u>linda.mcdonald@co.culberson.tx.us</u>.

## MONDAY, OCTOBER 22, 2018:

FIRST DAY to vote early in person.

Early Voting in person will be conducted in the County Clerk's Office, 300 Lacaverna St., during regular business hours.

HERE IS A LIST OF THE ACCEPTABLE FORMS OF PHOTO ID:

(Photo ID must be current OR expired no more than four years)

- Texas driver license issued by the DPS
- Texas Election Identification Certificate issued by DPS
- Texas personal identification card issued by DPS
- Texas license to carry a handgun issued by DPS
- U.S. military identification card containing the person's photograph
- U.S. citizenship certificate containing the person's photograph
- U. S. passport

HERE IS A LIST OF THE SUPPORTING FORMS OF ID THAT CAN BE PRESENTED IF THE VOTER DOES NOT POSSESS ONE OF THE FORMS OF ACCEPTABLE PHOTO ID AND CANNOT OBTAIN ONE DUE TO A REASONABLE IMPEDIMENT:

- VALID voter registration certificate
- Certified birth certificate (must be an original)
- Copy of <u>OR</u> original current utility bill
- Copy of <u>OR</u> original bank statement
- Copy of <u>OR</u> original government check
- Copy of <u>OR</u> original paycheck
- Copy of <u>OR</u> original government document with your name and an address (original required if it contains a photograph)

After presenting a supporting form of ID, the voter must execute a Reasonable Impediment Declaration form.

FRIDAY, NOVEMBER 2, 2018: LAST DAY to vote in person. TUESDAY, NOVEMBER 6, 2018:

General Election Day.

Polling places will open at 7:00 am and will close at 7:00 pm.
