1. **Property To Be Sold.** The property to be sold is described as follows:

All the real property described in the below described recorded Deed of Trust, including but not necessarily limited to:

ALL OF LOTS THREE (3) AND FOUR (4), IN BLOCK ONE HUNDRED TWENTY-SIX (126), TOWN OF VAN HORN, CULBERSON COUNTY, TEXAS.

2. **Date, Time, and Place of Sale.** The sale is scheduled to be held at the following date, time, and place:

Date: October 6, 2020

Time: The sale shall begin no earlier than 10:00 a.m. or no later than three hours thereafter. The sale shall be completed by no later than 1:00 p.m.

Place: On the south steps of the Culberson County Courthouse, 300 La Caverna Street, Van Horn, Culberson County, Texas, or in such other location as designated by the County Commissioner.

The deed of trust permits the beneficiary to postpone, withdraw, or reschedule the sale for another day. In that case, the trustee or substitute trustee under the deed of trust need not appear at the date, time, and place of a scheduled sale to announce the postponement, withdrawal, or rescheduling. Notice of the date of any rescheduled foreclosure sale will be reposted and refiled in accordance with the posting and filing requirements of the Texas Property Code. Such reposting or refiled may be after the date originally scheduled for this sale.

3. **Terms of Sale.** The sale will be conducted as a public auction to the highest bidder for cash, subject to the provisions of the deed of trust permitting the beneficiary thereunder to have the bid credited to the note up to the amount of the unpaid debt secured by the deed of trust at the time of sale.

Those desiring to purchase the property will need to demonstrate their ability to pay cash on the day the property is sold.

The sale will be made expressly subject to any title matters set forth in the deed of trust, but prospective bidders are reminded that by law the sale will necessarily be made subject to all prior matters of record affecting the property, if any, to the extent that they remain in force and effect and have not been subordinated to the deed of trust. Prospective bidders are strongly urged to examine the applicable property records to determine the nature and extent of such matters, if any.

4. **Type of Sale.** The sale is a nonjudicial deed of trust lien and security interest foreclosure sale being conducted pursuant to the power of sale granted by the deed of trust executed by URIAS ENTERPRISES, LLC. The deed of trust is dated December 21, 2010, and is recorded as Document No. 00000066348 in Volume 72, Page 763 of the Official Public Records of Culberson County, Texas, as modified by Modification and Extension of Real Estate Note and Deed of Trust

recorded as Document No. 00000001263 in Volume 9, Page 784 of the Official Public Records of Culberson County, Texas.



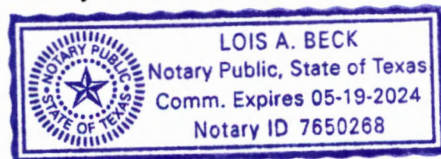


